

- Authorized completion of the revised visitors training manual

- Approved moving to a new and more costeffective office at Friends Center in Philadelphia in December 2020
- Continued our dedication as individual Board members to the mission and fiscal health of PVS, with a year-end \$10,000 challenge to our generous friends and donors to meet our 2020 annual fund goal - which was surpassed.

#### **PVS Hires New Executive Director**

After a thorough search process, the PVS Board of Directors hired Molly Clifford as Executive Director in August 2020. A native of Rochester, New York, Molly moved to Philadelphia about a month before the pandemic to be closer to her adult daughters and experience big-city living.

Molly's extensive experience with a variety of non-profit organizations, from the Golisano Children's Hospital to Mary's Place Refugee Outreach, as well as her service in several leadership posts in government and health care, made her an ideal candidate to lead PVS into its next chapter.

"I look forward to supporting PVS visitors so that they can do the best job possible for the people we serve," Clifford said. "Appreciating that PVS was founded in 1968, I also want to make sure the organization is financially healthy and structurally sound so that we can grow and thrive for the *next* 52 years!"

#### **Visitor Training Manual Update**

While we were prevented from visiting during the pandemic, PVS staff and volunteers were hard at work on several different projects. As a result, we are pleased to be able to offer our volunteer visitors a revised and updated training manual when they resume visiting in 2021!

One of the hallmarks of PVS visiting is our cadre of well-trained volunteers, a process not always easy to do given our national footprint and a small staff. We are blessed with an extremely strong team of volunteer local visitor coordinators, who work with our staff and training team to make sure our visitors have what they need to support the people we serve.

Our new manual, which will be available to visitors online, will be introduced throughout 2021 in regular Zoom sessions, interactive modules, and one-on-one support once it is safe to do so. Thank you to everyone who made this project a success!

#### Zoomin' PVS



Like the rest of the world, PVS has been using Zoom to keep in touch with our volunteers during the pandemic.

"The next best thing to being there" – Zoom has been a great way for us to communicate no matter where we're located, and we plan to keep using it even when the prisons re-open and we go back to "normal" life.



#### **Letter Writing During COVID-19**

In the spring of 2020, shortly after federal prisons closed down, the U.S. Bureau of Prisons decided to allow PVS volunteers to write letters to the people they had previously visited. While not optimal, letter writing has served as a reasonable alternative to face-to-face visits.

The PVS team quickly pivoted to support volunteers and prisoners in letter writing. Visitors use the PVS return address and letters from prison are scanned and emailed to the appropriate volunteers. To date, more than 1,000 letters have been received from people who are incarcerated in response to our volunteers; the number written to them is more than double that!

Once prisons re-open again, we expect our volunteers who are visiting to not be able to continue to write letters. While letter writing has allowed us to support incarcerated people in the only way we could, we are looking forward to getting back to our central mission: "to provide regular, face-to-face contact from the world outside of prison to help them cope with prison life and prepare for a successful re-entry into society."


### A Note from Inside



# **Visitor Recruitment**

In 2020, we received **98 applications** from prospective visitors, which is about half the number received in the prior year.

Despite the onset of the pandemic, we have continued to receive an average of 5 applications each month.

We have not appointed any new visitors since March when visiting at all federal prisons was suspended.

We currently have **350 active visitors**.

#### In Memory of Phil Carrigan


"Hi, I'm Phil, Phil Carrigan." If you've met Phil you'll remember his initial greeting, along with a big outstretched hand. A tall Irish-American guy with a big smile, he gravitated to people and loved to engage with others, one and all. Rare was the place we went that Phil didn't run into someone he knew. Almost everyone to Phil was "a good person" no matter one's history. All of this led to Phil being a really good PVS visitor. He joined in 1996, having been interviewed by Barbara Heater. Each month he visited at MCC-Chicago rarely missing a month until he stopped due to illness in June 2018.

Phil rarely missed a PVS conference. It was a great time for him to chat with others, sharing stories and insights. He never wanted the tour of the local prison but always wanted the other option of meeting with the prisoners. Phil was often a humorous player in the role plays, always in the prisoner role. Phil really connected with Jim Marren, former prisoner, PVS board member and current visitor.

Phil believed in PVS, its mission and the impact it had on the prisoners we saw. Phil and I gave significant annual donations to PVS and in his will, Phil made a bequest to PVS of \$10,000 in unrestricted funds. It was important to him that PVS continue. I continue to donate annually and also have made a bequest in my will for PVS.
